Eligibility Criteria:

1. Nominees should have contributed to a program that improves the lives of the homeless in Volusia and Flagler Counties. Those activities may include such things as homelessness prevention, fundraising for charities, etc.
2. Nominees should have made a significant contribution of any or all of the following: time, money, materials or other resources.
3. Nominees will be considered on their level of corporate contribution, impact of the contribution, broadness of impact, and the project's suitability as a role model for other corporate contributions.
4. The award is intended to recognize corporate or company-wide efforts.
5. Some portion of the nominee's contribution must have been received since July 2009, but ongoing efforts outside that time frame that demonstrate a depth of commitment will also be considered.
6. Nominations must be accompanied by a completed entry form to be considered. Corporate members may nominate themselves, or may be nominated by another individual or corporate representative.
